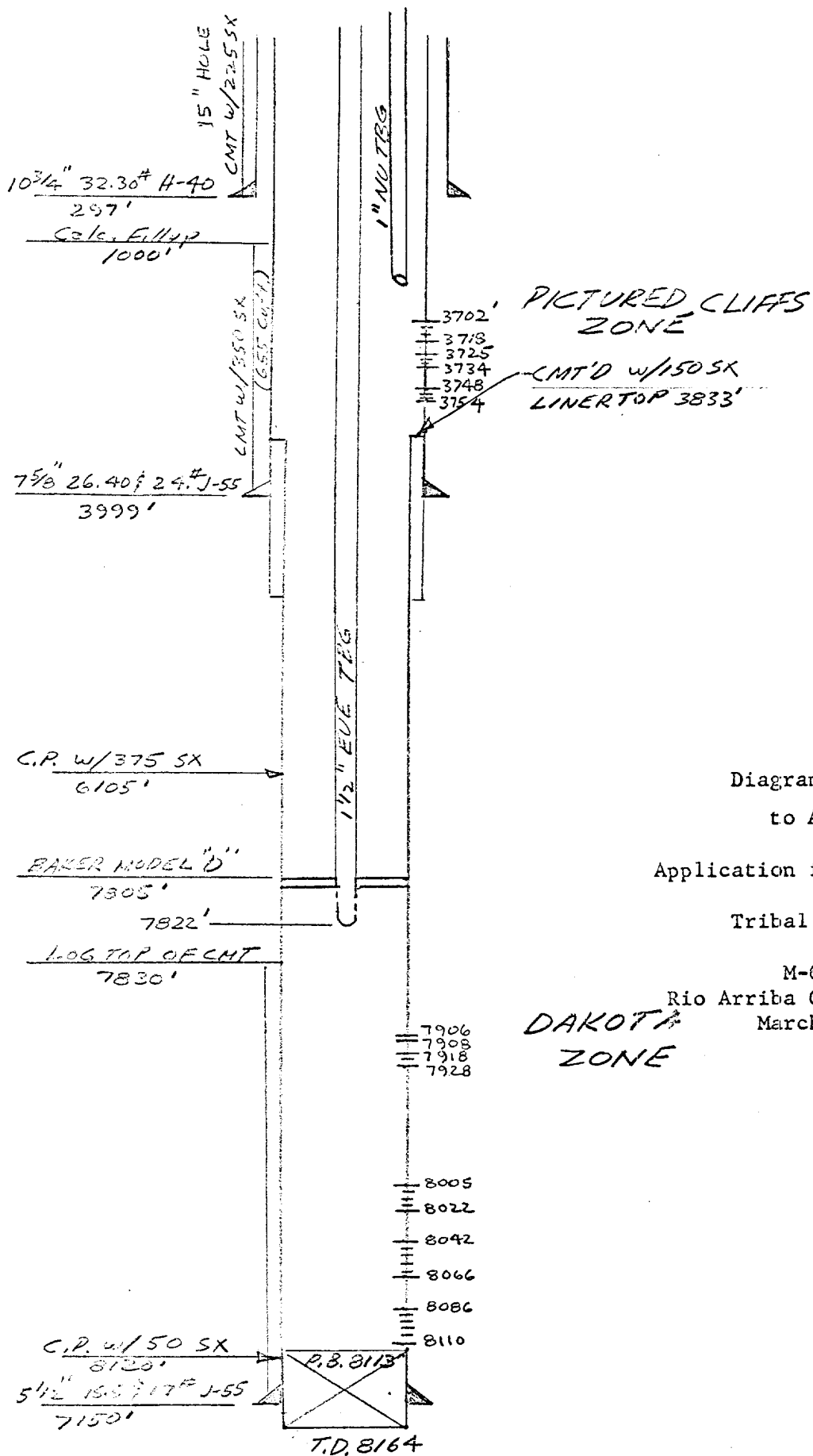

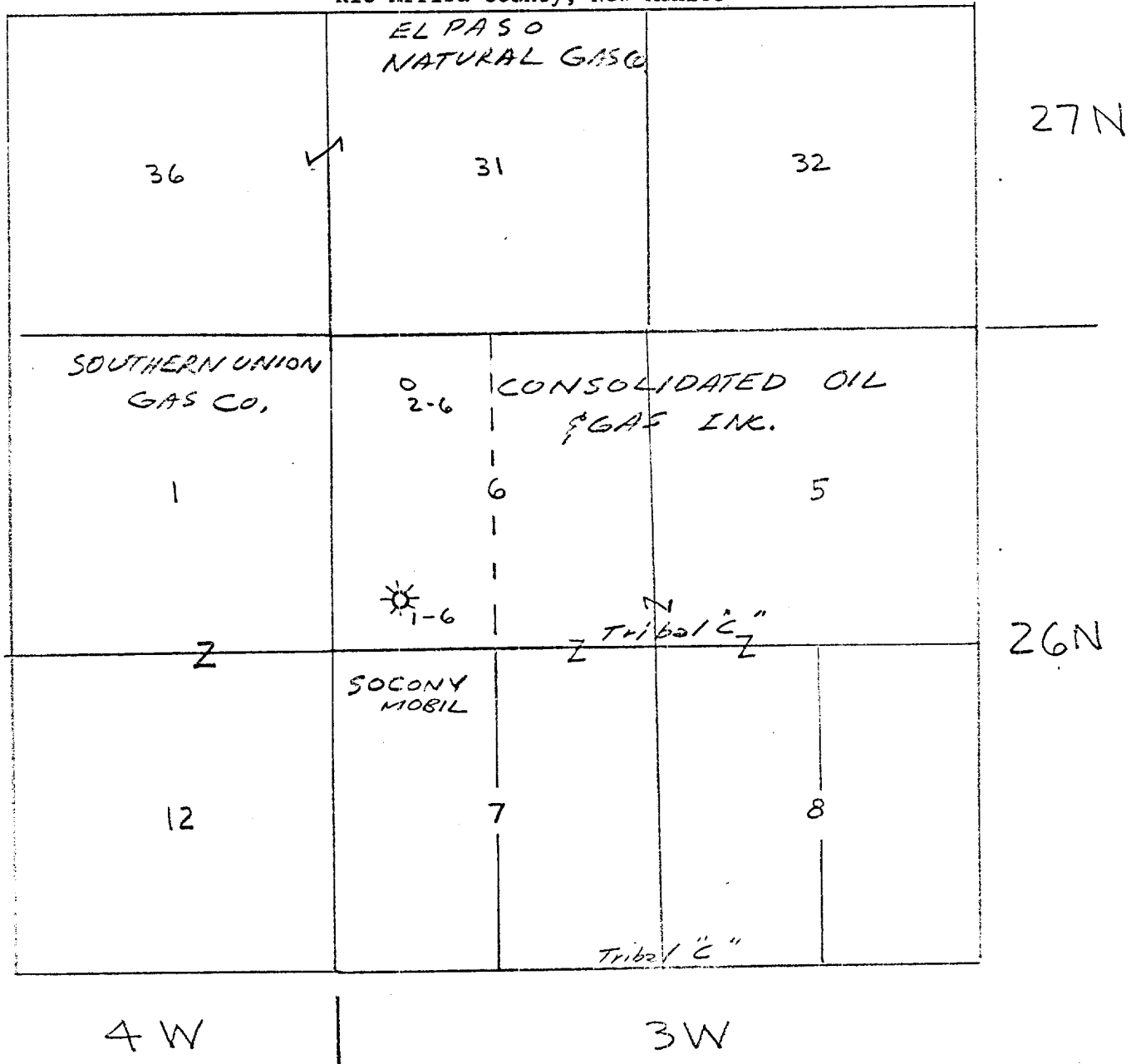
Diagrammatic Sketch

Application for Dual Completion

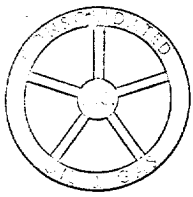

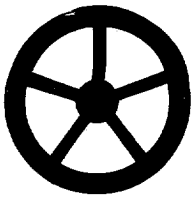
