THE APPLICATION OF HONOLULU OIL CORPORATION FOR PERMISSION TO EFFECT DUAL COMPLETION OF ITS JICARILLA APACHE WELL NO. 4, LOCATED IN THE NE/4 SW/4 OF SECTION 4, TOWNSHIP 26 NORTH, RANGE 4 WEST, NMPM, RIO ARRIBA COUNTY, NEW MEXICO, IN SUCH A MANNER AS TO PERMIT THE PRODUCTION OF GAS FROM THE BLANCO MESAVERDE POOL AND THE PRODUCTION OF GAS FROM THE TAPACITO PICTURED CLIFFS POOL.



## ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 112-A (c) Honolulu Oil Corporation, made application to the New Mexico Oil Conservation Commission on October 9, 1958, for permission to dually complete its Jicarilla Apache Well No. 4, located in the NE/4 SW/4 of Section 4, Township 26 North, Range 4 West, NMPM, Rio Arriba County, New Mexico, in such a manner as to permit the production of gas from the Blanco Mesaverde Pool, and the production of gas from the Tapacito Pictured Cliffs Pool.

Now, on this 28th day of October, 1958, the Secretary-Director finds:

- (1) That application has been duly filed under the provisions of Subsection 'c' of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

## IT IS THEREFORE ORDERED:

That the applicant herein, Honolulu Oil Corporation, be and the same is hereby authorized to dually complete its Jicarilla Apache Well No. 4, located in the NE/4 SW/4 of Section 4, Township 26 North, Range 4 West, NMPM, Rio Arriba County, New Mexico, in such a manner as to permit the production of gas from the Blanco Mesaverde Pool and the production of gas from the Tapacito Pictured Cliffs Pool, through the tubing and the casing-tubing annulus respectively.

PROVIDED HOWEVER, that applicant shall complete, operate, and produce said well in accordance with the provisions of Section V, Rule 112-A, as amended by Order R-1214.

PROVIDED FURTHER, that applicant shall take packer-leakage tests upon completion and annually thereafter during the Annual Deliverability Test Period for the Blanco Mesaverde Pool.

IT IS FURTHER ORDERED: that jurisdiction of this cause is hereby
