Set 4 1/2" 10.5# J-55 csg. @ 2234'. Cemented w/100 sks. Cl. H w/10% A-10B, 8# sk. gelsonite + 1% CaCl2 followed by 200 sks. Cl. H + 2% CaCl2. Circulated to surface. Cleaned out to 2214'. Ran CCL & GSL.

Perforated from 2118'-2138', 2164'-2184', 2 SPF. Acidized w/1000 gal. 15% HCL & 152 ball sealers. Frac w/70Q foam & 30 linear gel; 91,720# 20/40 Arizona sand and 10,020# resin coated sand w/472,000 SCF N2.

Drilled out to PBTD of 2229'. Ran 2 3/8" tbg., set @ 2170'. Put well on pump (2" x 1 1/4" x 7' x 10') RHAC-Z. Set pumping unit, tank, separator, compressor. Well turned to sales line 8/28/98.
