

DETAILS OF WORK

It is intended to drill a well with rotary tools thru the Mesa Verde formation. Mud circulation will be used thru the Pictured Cliffs and set intermediate casing. Casing Program:

10 3/4" at 170' with 150 sacks cement circulated to the surface.
7 5/8" at 3027' with 250 sacks cement.
5 1/2" liner at 5285' with 300 sacks cement.




