Perforated 2121'-2154'; 2164'-2194'; 1 SPF, 64 holes. Acidized w/1000 gal. 15% HCL. Frac'd w/70Q N2 foam. Used 382,000 SCF N2; 91,120# 20/40 Arizona sand; 12,180# resin coated sand.

Ran 2 3/8" tbq, set @ 2181'. Put well on 2" x 1 1/4" x 7' x 10' RHAC-Z BHP. Set pumping unit, separator, tank and compressor. Turned well to sales 12/23/98.
