
Dear Sir:

We propose to drill the subject well to a projected depth of 6500'. It is further proposed to dually complete this well in the Pictured Cliffs and Mesa Verde Zones.

We further propose to set 10 3/4" surface casing at approximately 321', 7 5/8" intermediate casing at approximately 4100', and set a 5 1/2" liner on bottom. We will perforate in the Pictured Cliffs Zone and in the Mesa Verde Zone and attempt a dual gas completion. Dual tubing strings will be run.

The subject well is located 990' FNL and 990' FEL in the NE 1/4 of Section 2.
