Spud 4:00 P.M. 3-17-64. Drilled 310' of 17" hole. Ran 9 joints of 12 5/4" casing set at 310' KB. Cemented with 280 sacks regular with 2% Ca Cl₂. Pressured to 10000 Psi. Drilled 3759' of 10 5/8" hole. Ran 115 joints of 7 5/8" J-55 casing. Set at 3756 KB. Cemented with 195 sacks of 50-50 Pen-mix with 4% Gel. Filled in with 50 sacks of regular with 2% Ca Cl₂. Plug down 10:30 P.M. 3/26/64. Gas drilled 6 3/4" hole to 7970' KB. Set 5 1/2" 15.50# J-55 casing from 3643' to 7963' KB. Cemented with 320 sacks 50-50 pen-mix with 4% gel. Plug down 2:00 P.M. 4/3/64.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
