It is proposed to recomplate this well from the Basin Dakota Pool to the Blanco Mesaverde by the following procedure:

1. Set RBP @ +5600' above the Dakota.
2. Run Gamma Ray for correlation and perforate Mesaverde from 5160'-5480'.
3. Pump 15% HCL and fracture stimulate the Mesaverde.
4. Clean out wellbore to the RBP @ 5600'.
5. RIH w/2-3/8" production string and produce the Mesaverde.

Also attached is a new C-102 for the Mesaverde completion.

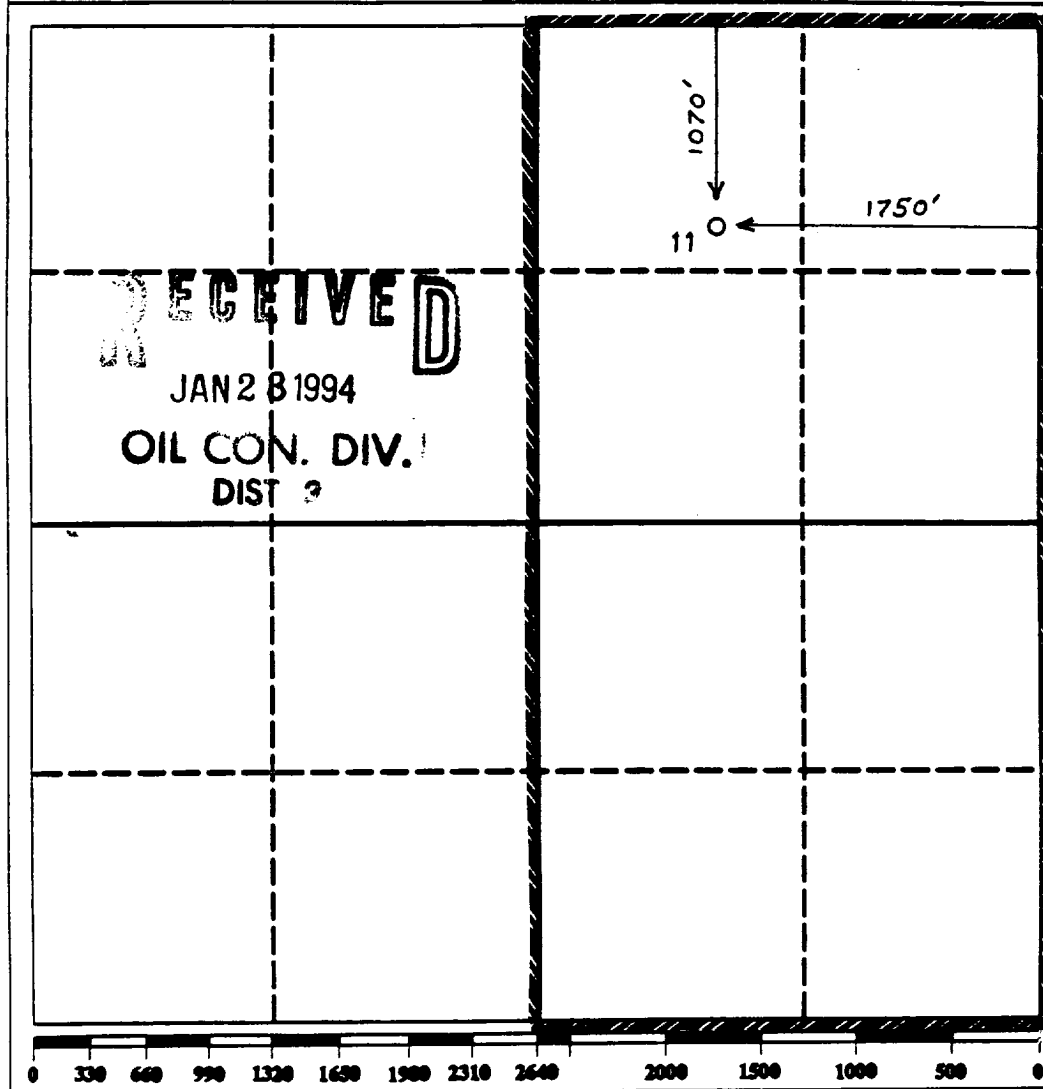
