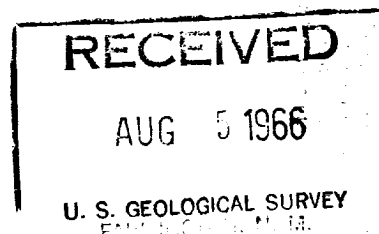

1. Spudded 12-1/4" surface hole July 27, 1966. Drilled to total depth of 310 ft. R.K.B.
2. Ran 9 jts. of 8-5/8", 24.0#, J-55 surface casing. Landed at 308 ft. R.K.B. Cemented w/250 sacks cement containing 2% Calcium Chloride. Plug down 7:45 A.M. July 28, 1966.
3. Nippled up and pressure tested surface casing and B.O.P. to 800 psi for 15 minutes July 28, 1966. Test OK.
4. Drilled out from under surface casing with 7-7/8" hole.
