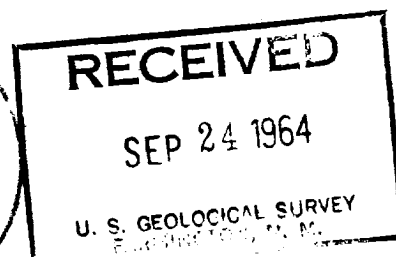
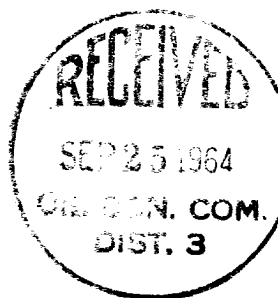

This well has been perforated, fractured and cleaned up in the Dakota zone. A potential test of Dakota gas production will be made 9-26-64, after the well has been shut in 168 hours.

After the potential test has been completed it is proposed to set a bridge plug at approximately 7420, then perforate and test the Toole zone 6976 to 6995. If the well does not produce satisfactorily natural, it is further proposed to sand/oil fracture it using Toole crude oil and a maximum of 40,000# 20-40 sand
