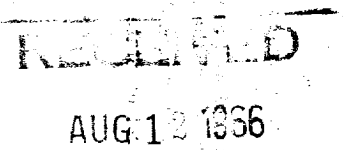
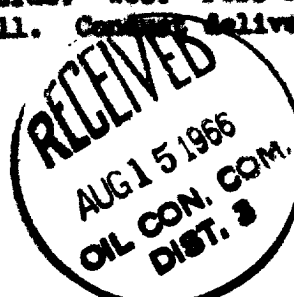

We plan to drill to approximate T.D. 7665'. Run IBS and GR-Density logs. Run casing as shown above with stage collar set approximately 300' below bottom of Mesaverde. WOC. Perf and frac and complete as a single Basin Dakota gas well. Conduct deliverability tests. Run 2-3/8" tubing.

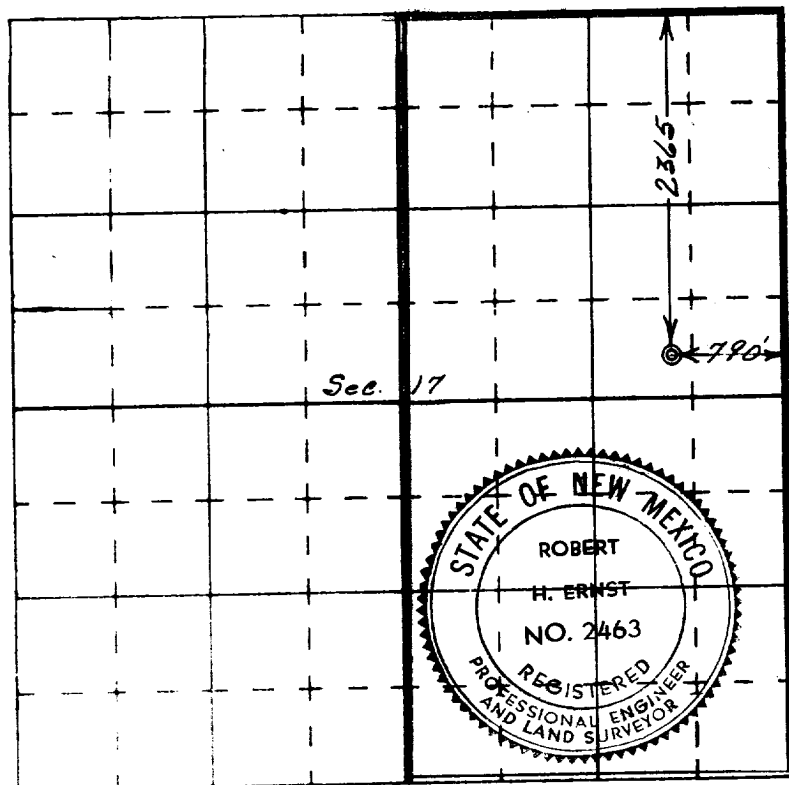
