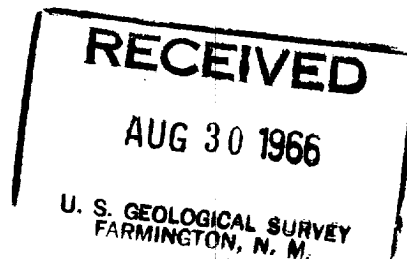

7-26-66 Sand-oil fractured from 2174' to 2288' with 1,696 barrels crude oil, 60,000# 20/40 sand and 45,000# 10/20 sand. Average overall injection rate 34 barrels per minute. No apparent breakdown pressure. Average treating pressure 2600#, minimum 2500#, maximum 4300#. Instantaneous shut-down pressure 400#, 10-minute SIP zero.

7-31-66 Ran tubing to 2128'. Ran rods. Started pumping load oil.

8-23-66 After recovery of load oil, well pumping at rate of 80 barrels net oil per day.
