A 12 1/4" hole will be spudded and drilled to 200'; 8 5/8" surface csg. will be run and cemented to surface. A 7 7/8" hole will then be drilled to sufficient depth to test the Dakota formation, approx. 700'. If commercial production is indicated 4 1/2" production casing will then be run and cemented in three stages. The first stage will be cemented w/400 sx., and second stage through stage prod. below reservoir w/660 cu. ft. and the third stage through stage tool joint below Dakota formation w/800 cu. ft. The Dakota formation will then be surf. bsg. run and the well completed.

Instructions

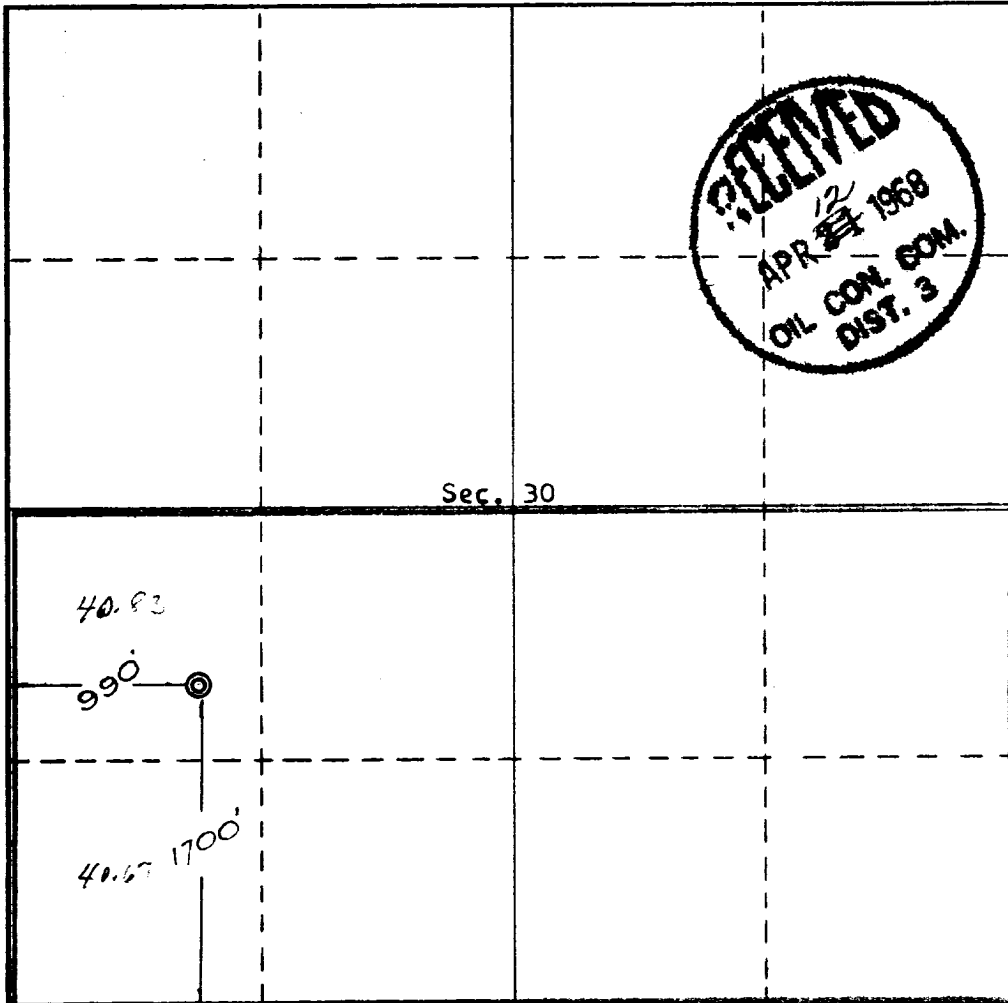
