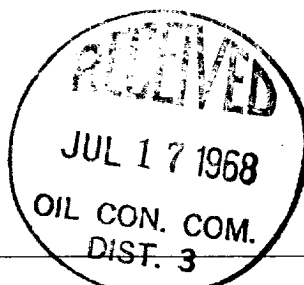

1. Spudded 9-7/8" hole 12:30 P.M., June 21, 1968. Drilled to T.D. of 668 ft. R.K.B.
Reamed 9-7/8" hole to 13-3/4" hole to T.D. of 520 ft. R.K.B.
2. Ran 17 jts. of 10-3/4", 32.75#, H-40 surface casing. Landed at 520 ft. R.K.B.
Cemented with 350 sacks regular cement with 2% Calcium Chloride and 1/4" flo-cela/sk.
Plug down 9:00 A.M., June 25, 1968. Cemented circulated to surface.
3. Nipped up and pressure tested surface casing and blowout preventer to 800 psi
for 10 minutes. Test OK.
4. Drilled out from under surface casing w/9-7/8" hole on June 25, 1968.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
