

## Instructions

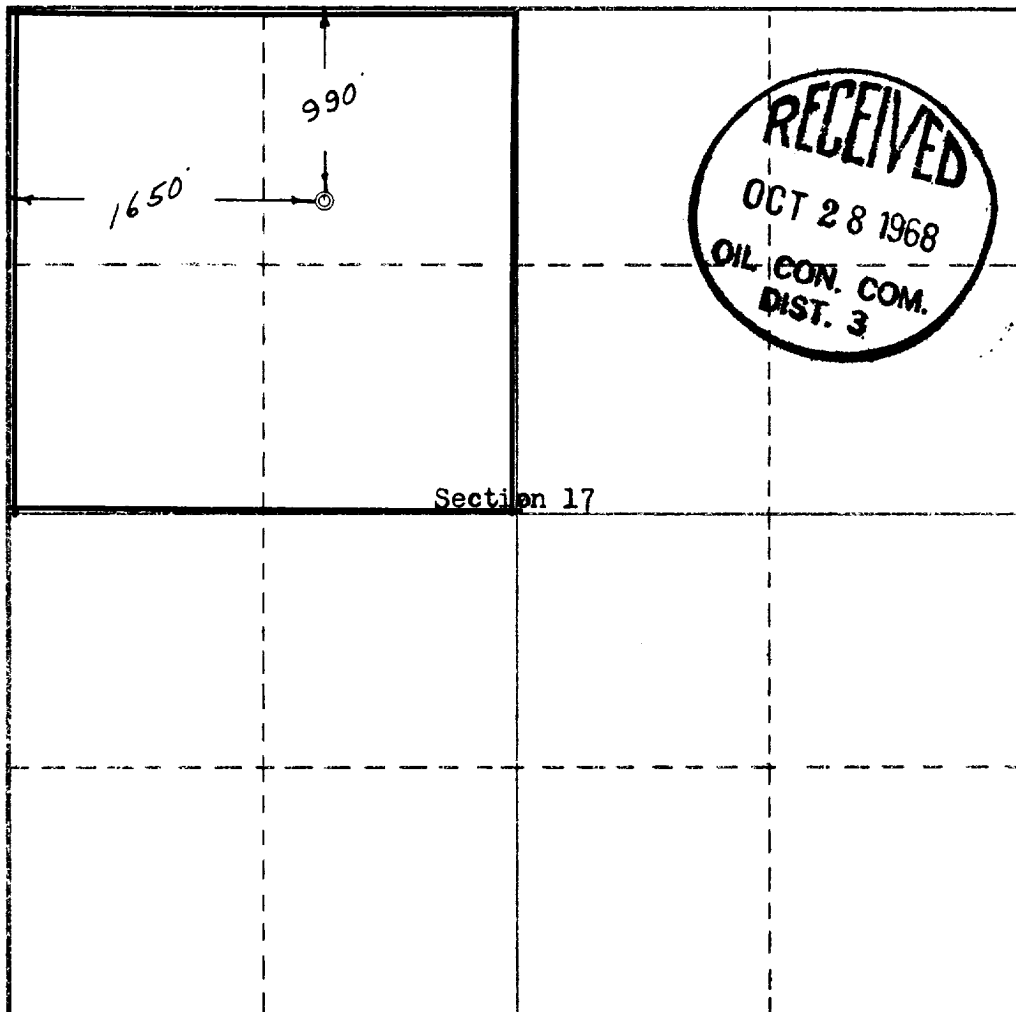
