1. Spudded 12-1/4" surface hole January 2, 1969, drilled to total depth of 340 ft. R.K.B.

2. Ran 10 jts. of 8-5/8", 24.0#, J-55 surface casing. Landed at 337 ft. R.K.B. Cemented w/225 sacks regular w/2% C.C. and 1/4# flo-calc/sk. Plug down 1:30 P.M. January 3, 1969. Cement circulated to surface.

3. Nipped up and pressure tested surface casing and blowout preventer to 1000 psi for 15 minutes. Test OK.

4. Drilled out from under surface casing w/7-7/8" hole w/mud on January 4, 1969.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands, pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
