1. To be completed by: Test the Gallus formation in addition to the Mesaverte and back to the main well as originally filed in the application for permit to drill (Form 9-15C) filed October 17, 1960.
2. If well is non-productive the well will be tested and completed by using 3", 1.90% S.U.E. tubing to back to 10, 1.75% Integral joint tubing to Gallus and conducting Mesaverte thru annulus. Baker 5 1/2" Model "B" packer will be set approximately 3000 ft. on Dakota tubing and Baker 5 1/2" Model "BA" Packer will be set on Gallus tubing at approximate depth of 2000 feet.
3. If well is non-productive, it will be plugged off with a cement approximately 150 sacks of cement.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
