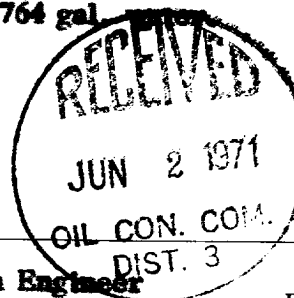

5-18-71 T.D. 7544'. Ran 2x 243 joints 4 1/2", 11.6# and 10.5# KS casing (x 7532') set at 7544'. Float valve at 7529', stage tools at 5408' and 3087'. Cemented first stage w/310 sacks, second stage w/215 sacks, third stage w/180 sacks. W.O.C. 18 hours.

5-20-71 P.B.T.D. 7517'. Perforated 7380-88', 7402-10', 7422-30' and 7440-48', fraced w/17,040# 20/40 sand, 22,596 gal. treated water. Dropped 1 set of 24 balls, flushed w/5922 gal. water. Perforated 7128-36', 7148-56', 7233-49', 7274-82', 7306-14', fraced w/60,000# 20/40 sand, 64,428 gal. water. Dropped 4 sets of 24 balls each, flushed w/1764 gal. water.

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
