The current gas price has not improved over the past year, hence a workover at this time would not be economically feasible. Given our current high level of activity in the area and other time constraints, Union Oil Company of California (dba Unocal) requests an additional six (6) month temporary shut-in status for this well in order to allow time to fully evaluate its remaining potential.
