1. Drilled 7-7/8" hole to T.D. of 3910 ft. R.K.B. Reached T.D. on 9-11-74.
2. Ran IES and Density logs.
3. Ran 103 jts. of 4-1/2", 9.5# Casing. Landed at 3909 ft. R.K.B. 4-1/2" Stage Collar set at 2602 ft. R.K.B. Cemented 1st stage w/285 sacks. Cemented 2nd stage with 267 sacks.
4. Moved in Completion Rig on 11-7-74. Rigged up and ran tubing and bit. Drilled out stage collar at 2602 ft. R.K.B. Cleaned out to P.B.T.D. of 3881 ft. R.K.B.
5. Pressure tested casing to 2800 psi. Test OK.
6. Ran cement bond and Gamma-Ray Correlation logs.
7. Perforated Pictured Cliffs some 1 shot/ft. from 3818 - 3850 ft. Total of 33 holes.
8. Send Water fraced perfs using 70,000# sand and 73,000 gallons of water.
9. Ran 1-1/2", 2.9#, E.U.E. tubing. Landed at 3720 ft.
10. Well completed November 11, 1974.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
