Water for drilling and completion operations will be obtained from the following location: Superior Water Hole #1, NWNW 4-25-6.

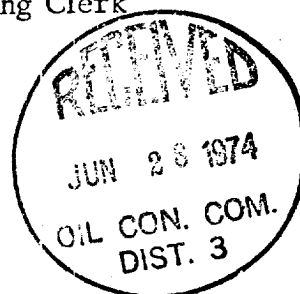

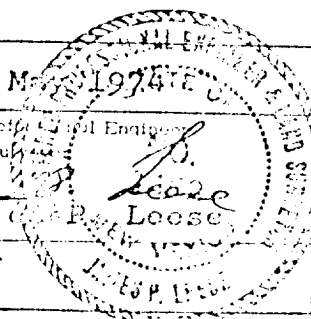

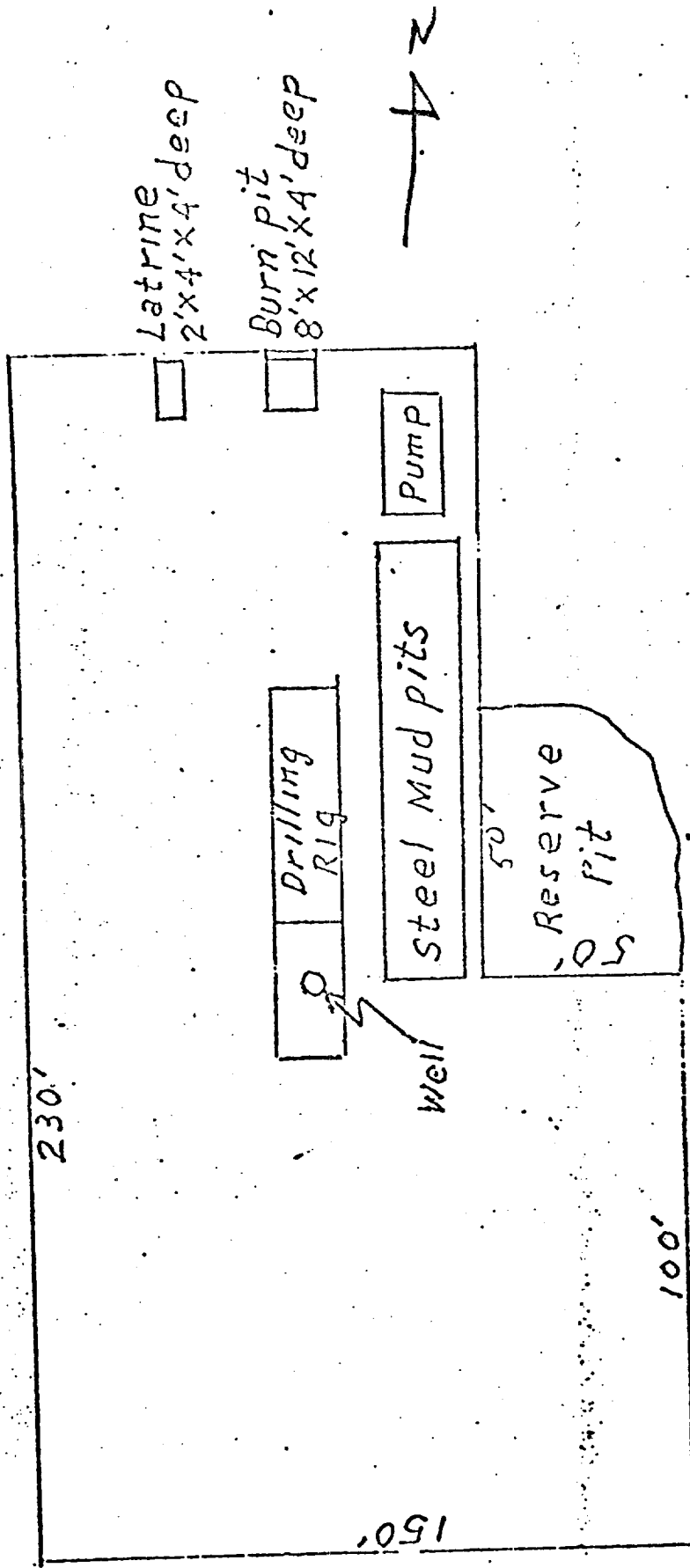

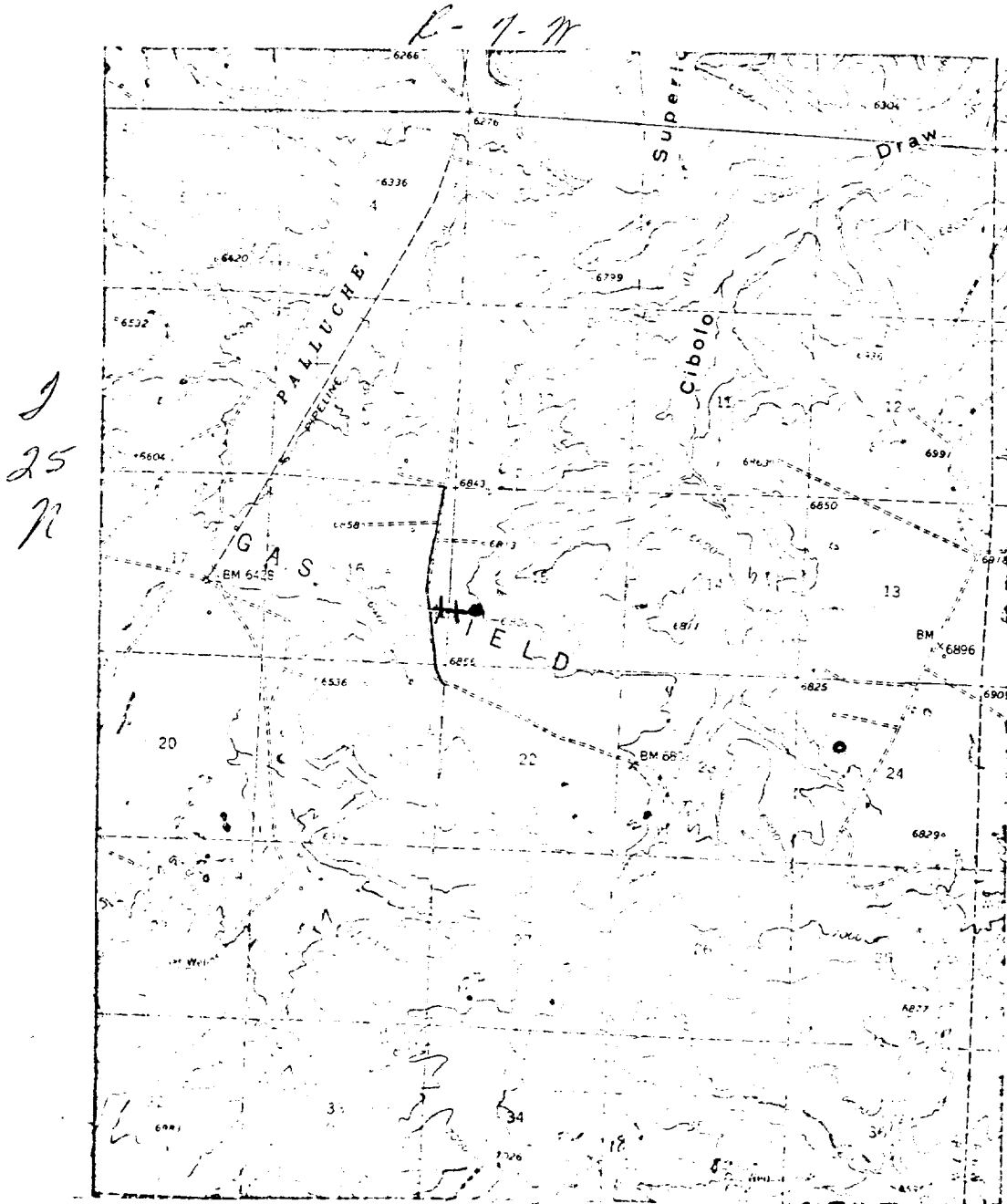


LOCATION AND EQUIPMENT LAY-OUT
