Plug #2: Pump 19 sx Class "B" neat cmt inside csg @ 1313-2000'. TOOH. Circ hole clean. WOC. Load hole w/3 bbl wtr. TIH, tag TOC @ 1260'. TOOH. PT csg to 500 psi, failed. TIH, perf 2 sqz holes @ 300'. TOOH. TIH w/2 7/8" cmt retainer, set @ 260'. Plug #3: pump 85 sx Class "B" neat cmt outside csg. Pump 8 sx Class "B" neat cmt inside csg to surface. Circ 6 sx cmt to surface. WOC. ND BOP. Cut off WH.
