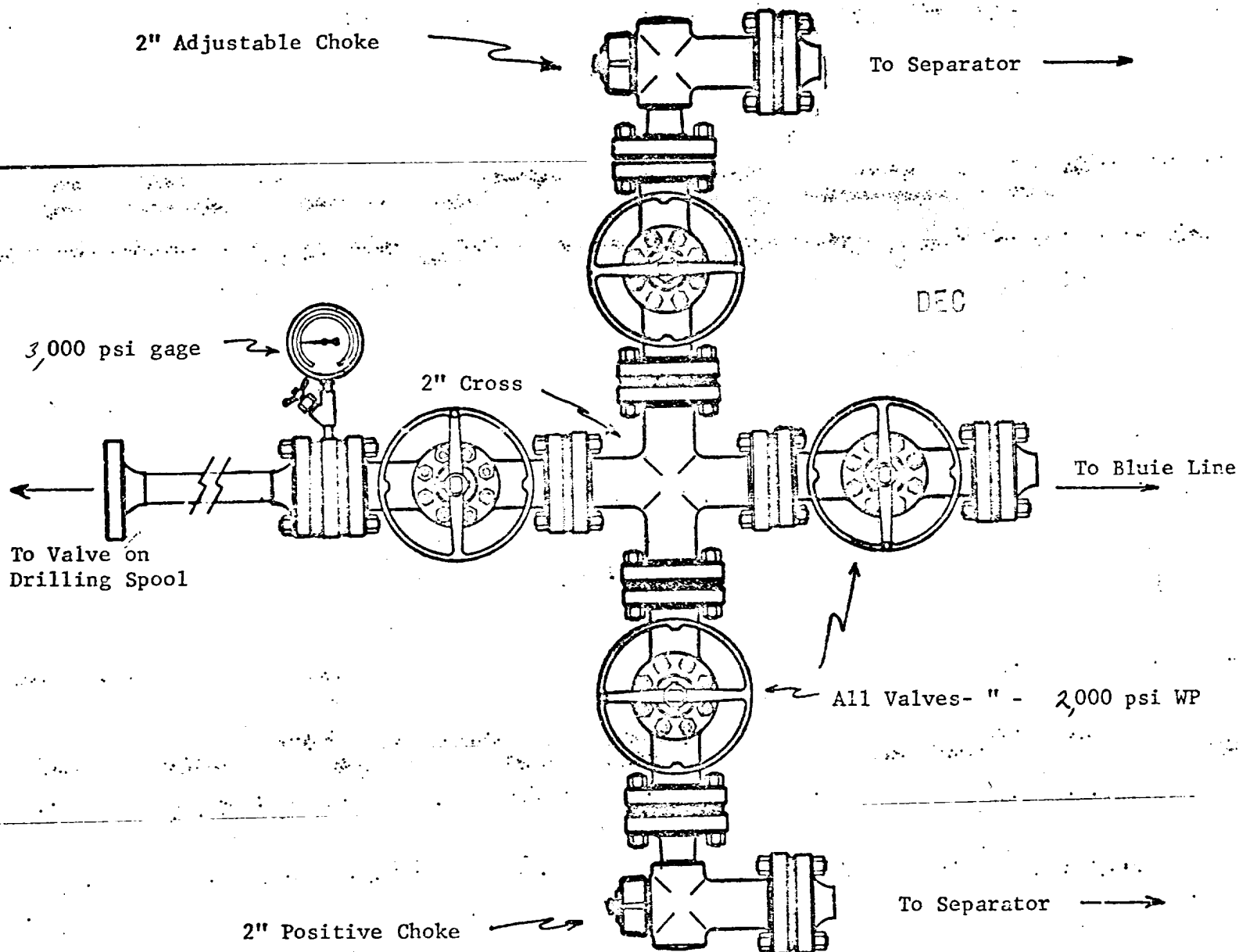
Instructions

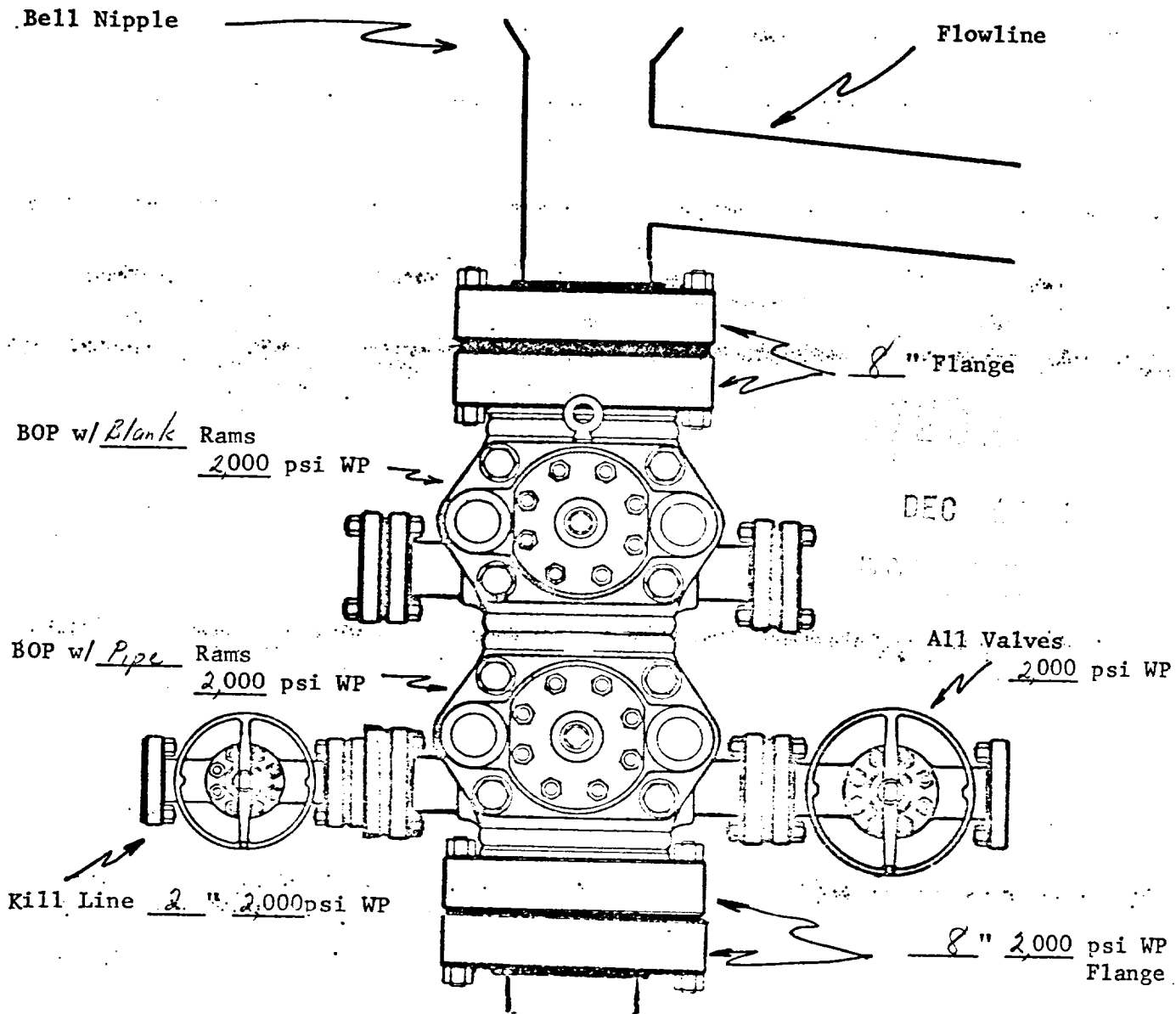

8 5/8 " CASING STRING

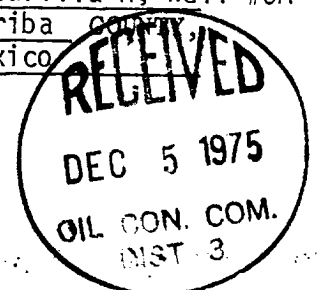
