The proposed new well location, new roads and new pipeline are shown on the attached plat along with connecting existing roads and pipelines in the vicinity of the proposed new well.


Water for drilling and completion operations will be obtained from a water hole located in Section 18, T-27-N, R-4-W (Jaramillo Water Hole).

Upon completion or abandonment of this well, the location will be cleaned and leveled and a dry hole marker placed, if applicable.
