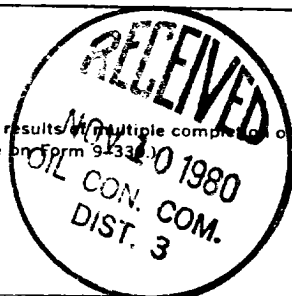

1. Drilled 7-7/8" hole with mud to total depth of 7624 ft. R.K.B. Reached total depth on 10/31/80.
2. Ran 240 joints of 4-1/2", 10.50#, K-55 casing. Landed at 7624 ft. R.K.B. Float collar at 7589 ft. R.K.B. D.V. tools set at 5533 and 3217 ft. R.K.B.
3. Cemented first stage with 350 sacks of 50-50 poz mix with 2% gel and 10% salt. Plug down at 5:45 P.M. 11/1/80. Cemented second stage with 430 sacks of 50-50 poz mix with 2% gel and 6-1/4 lb. of Gilsonite per sack and 50 sacks of class "B" with 2% calcium chloride. Plug down at 8:45 P.M. 11/1/80. Cemented third stage with 200 sacks of Howco Lite with 12-1/2 lb. of Gilsonite per sack and 10% salt and 50 sacks of class "B" with 2% calcium chloride. Plug down at 11:45 P.M. 11/1/80.
4. Ran temperature survey and found cement top at 1000 ft. R.K.B.
