1. MIRU. TOH with 2-3/8" tubing and Packer.
2. TIH and set RBP at 5800'. TOH. TIH with packer and set at 5400'. Squeeze off Cliff House with 100 Sx cement. WOC
3. TOH. TIH and drill out. Test squeeze to 500 psi. TOH. TIH and retrieve RBP.
4. TIH and clean out to PBTD with air mist. Land tubing at 6420 and return to production.
