McElvain proposes to permanently abandon the zones below the Pictured Cliff by capping the existing CIBP at 5670' with 35' of cement with a dump bailer. The 33 Lewis perfs (4468'-5571') will be isolated by setting a CIBP at +/- 4086' (Lewis top), pressure testing the CIBP to 1000 psig and capping the CIBP with 35' of cement with a dump bailer.

Permanent abandonment of lower zones previously approved on November 15, 1999.

The Pictured Cliffs zone will then be completed.
