Union Texas Petroleum wishes to advise that a 7-7/8" hole was drilled to 8255' KB. Run 5-1/2", 17#, 20#, 23#, 26# casing (DV tools @ 6285' KB and 3960' KB) to 8248' KB. Cement to surface in three stages as follows:

1st Stage - 400 sxs (628 cu.ft.) 50/50 POZ containing 4% gel, 6-1/4# gilsonite/sk and 10# salt/sk. Open DV tool, circulate cement to surface.

2nd Stage - 670 sxs (1052 cu.ft.) 50/50 POZ containing 4% gel, 6-1/4# gilsonite/sk and 10# salt/sk. Lost returns on displacement. No cement circulated when DV tool opened.

3rd Stage - 600 sxs (1722 cu.ft.) 65/35 POZ containing 12% gel and 12-1/4# gilsonite/sk. Lost returns on displacement. Temp survey run 12/1/86 indicates anomaly at 1500' KB.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
