- 04/02/02 RU wireline. Add perfs at 5979,5980,5988,5990,5998,6000,6019,6020 w/1 JSPF.
- 04/03/02 Acidized perfs with 1000 gals. 15% HCL and fraced with 101,649 gals 60Q foam slickwater and 100,000# 20/40 sand. Flow well back for cleanup.
- 04/11/02 TIH and clean out to 6173' with air mist. Land 2-3/8" tubing @ 5990'. NU wellhead. Swab well in and return to production.
