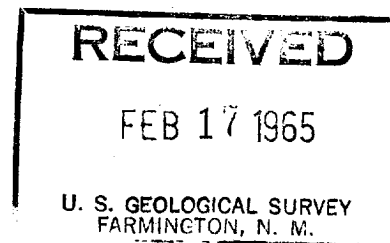

Moved in and rigged up pulling unit. No rods or tubing in well. Ran sand pump and cleaned well out from 5345' to 5353'. Ran 2" tubing and set packer at 5236'. Installed Water Injection Equipment and started injecting water into the Gallup Formation through 5-1/2" OD casing perfs. 5286-5336' on FEB 13 1965.

This well is a Water Injection Well for the East Bisti Unit.

Instructions
