7/17/71 MI & RU Aztec Well Service Unit. Pulled rods. Spotted cement plug 5217-5117'. Pulled 2" tubing. Worked 5-1/2" casing to free same. Rigged up blue jet and perforated 1584-1585' with 4 shots. Ran 2" tubing. Spotted cement plug 1585-1435'. Pulled tubing. Shot casing off at 1302'. Spotted cement plug 1352-1252', 50' inside of casing and 50' above casing stub. Pulled up casing. Spotted cement plug 790-690'. Pulled 5-1/2" casing (1307') 39 jts.

Spotted 10' cement plug in surface casing. Installed dry hole marker.
