First Plug - (5047'- 5147') 100' plug across the Gallup Zone Perfs. 5094-5123'

Second Plug- 50' inside of the 5-1/2" casing and 50' above where casing is shot in two

Third Plug - (1390'- 1540') 150' plug extending downward from above the Fruitland coal section across the Pictured Cliffs Sand

Fourth Plug- (660'- 760') 100' plug extending from 50' above to 50' below the bottom of the Ojo Alamo Sand

10 sacks of cement in top of surface casing with dry hole marker
