DETAILS OF WORK

We propose to drill this well with rotary tools to a sufficient depth to test Gallup Sand, at approximately 5200'.  
We propose to set 275' of 2 5/8 csg. and cement to surface.  
We expect to drill through Gallup Sand Section to an approximate depth of 5200' and if productive set 5 1/2" csg. through zone, cementing to 500' above pay zone.  
Perforate and sand oil frac if necessary for completion.

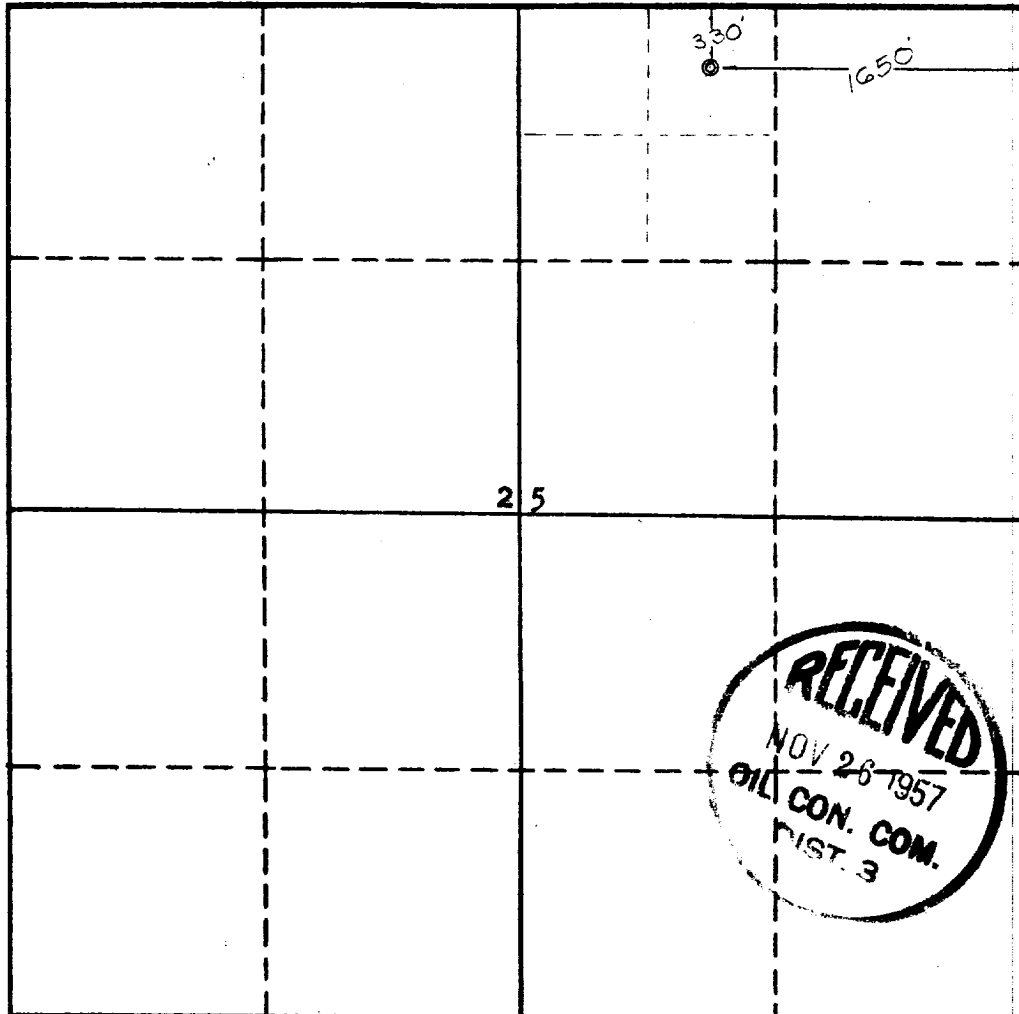
