Third Plug - (1225' - 1375') 150' plug extending downward from above the Fruitland coal section across the Pictured Cliffs Sand

Fourth Plug- (435' - 535') 100' plug extending from 50' above to 0' below the bottom of the Ojo Alamo Sand

10 sacks of cement in top of surface casing with dry hole marker
