Nipple up cementers, est circ. @ 4696' w/20 bbls H2O. Circulate clean H2O. Pump 10 sx Class "B" cement on top of CIBP set @ 4698'. POOH w/tubing to 3925' - pump 15 sx Class "B" cement. RIH w/wireline - tag cement @ 3820'. Perf csg @ 1989'. RIH w/cement retainer and set @ 1947'. Pressure up csg to 500 PSI - held for 5 minutes. Pump 30 sx Class "B" cement outside csg and 17 sx inside csg. RIH w/wireline perf. @ 1260' - set retainer @ 1236' - pump 30 sx Class "B" cement outside csg and 17 sx Class "B" inside csg. RIH w/wireline perf. csg @ 938' - set cement retainer @ 896' - pump 30 sx Class "B" behind csg and 17 sx Class "B" inside csg. RIH w/wireline perf. csg @ 372'. Nipple up wellhead - pump down csg and est. circulate out of bradenhead. Pump 105 sx Class "B" cement to surface. Plugging complete.
