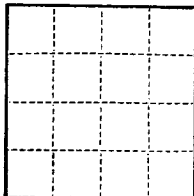

It is our intention to drill Well No. 1 to approximately 5200' to test the Gallup formation. Our casing program is as follows:

425' of 10-3/4" OD 32.75# casing, cemented with 400 sacks reg. cement, to be circulated.

5200' of 5-1/2" OD 14# casing, cemented with 200 sacks reg. cement.

The designated drilling unit is the NW 1/4-NE 1/4 of Section 21-29N-11W, San Juan County, New Mexico.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

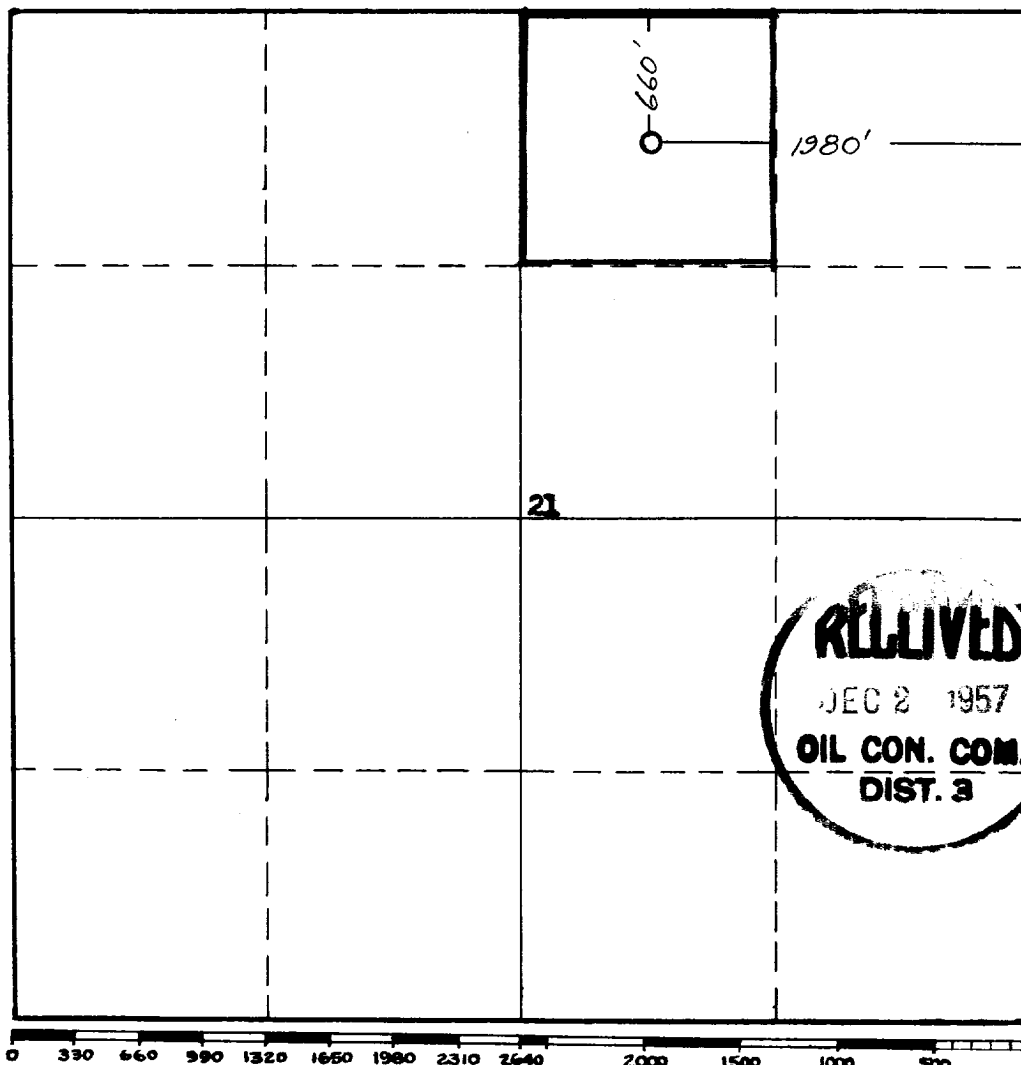
