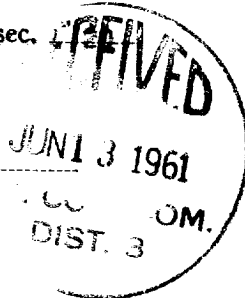

DETAILS OF WORK

Proposed work

1. Drill 1 1/2-3/4" hole to 60'.
2. Run and cement 10-3/4", P-40, 40.55 casing at 60' with 50 sacks cement treated with 2% calcium chloride.
3. Drill 2" hole to 350 (point lookout).
4. Run and cement 7" J-55, 23#, 87 & C casing at 350 with 270 sacks cement treated with 1% and calcium chloride.
5. Perforate and sand water frac select intervals between 2500 and 3500.
6. Complete as a water source well.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

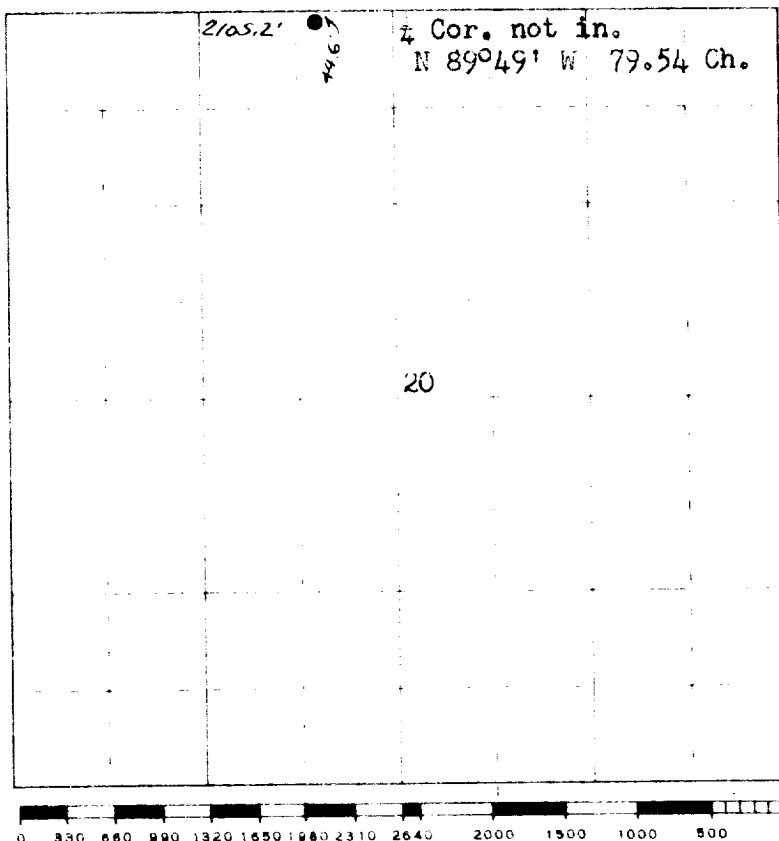
