Central Resources, Inc. intends to plug the well in accordance with regulations. Production equipment will be removed and the well will be plugged as specified. **Perforate and squeeze will be used unless casing can be recovered over the specified interval or there is evidence cement is in place behind the casing.**

Proposed procedure:

- Notify the Farmington BLM office at 505-599-8907 24 hours prior to commencement of plugging operations.
- Pull all retrievable downhole production equipment.
- Spot a 100' plug from 4758' to 4658' across the top of the Upper Gallup at 4718'.
- Tag plug before moving up hole.
- Spot a 100' cement plug from 3852' to 3752' across the top of the Mancos at 3802'.
- Spot a 100' cement plug from 2103' to 2003' across the top of the Menefee at 2053'.
- Spot a 100' cement plug from 1200' to 1100' across the top of the Pictured Cliffs at 1150'.
- Spot a 155' cement plug from 155' to surface across the surface casing shoe at 105'.
- Cut wellhead and install dry hole marker. Clear and remediate location.

Please take into account the number of existing P&A procedures, the number of P&A procedures you have requested and the available equipment and allow Central Resources, Inc. until the end of 2001 to complete this abandonment.
