Elm Ridge Resources, Inc proposes to plug and abandon the E.W. Mudge #6 in accordance with regulations. Production equipment will be removed from the well and tubing will be used to pump plugs. Perforate and squeeze will be used unless casing can be recovered over the specified interval. Proposed procedure: Notify the BLM office 24-hours prior to commencement of plugging procedure. Set a CIBP @ 4720'. Set a 50' cement plug from 4670' to 4720' across Gallup top of 4720'. Set a 100' cement plug from 1955' to 2055' across top of Mesa Verde top of 2005' inside and outside of 4-1/2 casing. Set a 230' cement plug from 1140' to 1370' across top of PC/FC PC top @ 1320' FC @ 1190' inside and outside of 4-1/2 casing. Set a cement plug from surface to 361' across top of Ojo Alamo top @ 311' inside and outside of 4-1/2 casing. Cut off wellhead. Install dryhole markers. Clean and remediate location.
