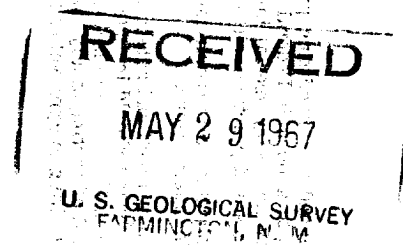

Reason for workover was to convert well from oil producing to water injection status.

Procedure was as follows:

Moved in pulling unit and commenced workover on 3/21/67. Pulled rods and tubing. Ran 2-3/8" tubing with Baker Model R injection packer and set packer at 4851'. Loaded casing annulus with inhibited water and installed injection wellhead. Injected 557 barrels of water into well on 24 hour test ending 9:15 PM on 4-5-67.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
