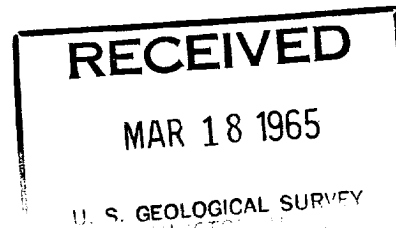

8-5/8"	32	300	150 sacks
4-1/2"	11.6	6750	250 sacks

Drill 8-1/4" hole to 300', set 8-5/8" casing and cement to surface. Mud
 drill 4-1/2" hole to 6750' KB. Run 4-1/2" casing to total depth and cement
 250 sacks. WOC for 24 hrs. and pressure test. Selectively perforate,
 sand water frac and complete as a single zone Dakota well.
