5. Perforate four holes/ft. selected intervals 4800-4915'.
6. If applicable, sand oil fracture with 30,000 gal. crude oil and 1-2 1/2 gal sand.
7. Shut well into production, establish initial rate.

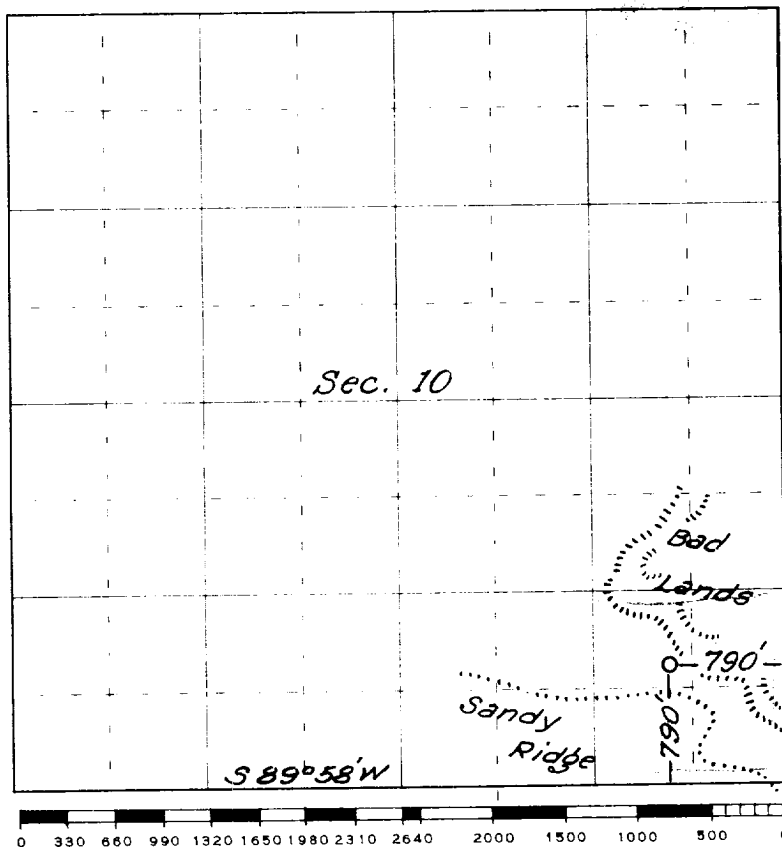
