Central Resources, Inc. intends to plug the well in accordance with regulations. Production equipment will be removed and the well will be plugged as specified. **Perforate and squeeze will be used unless casing can be recovered over the specified interval or there is evidence cement is in place behind the casing.**

Proposed procedure:

- Notify the Farmington BLM office at 505-599-8907 24 hours prior to commencement of plugging operations.
- Pull all retrievable downhole production equipment.
- Set a CIBP at 4700' and spot 50' of cement on top.
- Set a 100' cement plug from 1822' to 1922' across Menefee top at 1872'.
- Set a 100' cement plug from 988' to 1088' across the Pictured Cliffs at 1038'.
- Set a 100' cement plug from 578' to 678' across the Fruitland Coal at 628'.
- Set a 100' cement plug from 265' to 365' across the surface casing shoe at 315'.
- Set a 50' cement plug from surface to 50'.
- Cut wellhead and install dry hole marker. Clear and remediate location.

Please take into account the number of existing P&A procedures, the number of P&A procedures you have requested and the available equipment and allow Central Resources, Inc. until the end of 2000 to complete this abandonment.
