13. Describe Proposed or Completed Operations (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Elm Ridge Resources, Inc proposes to plug and abandon the CBU #32 in accordance with regulations. Production equipment will be removed and tubing will be used to pump plugs. Perforate and squeeze will be used unless casing can be recovered over the specified interval. Proposed procedure as follows: Notify BLM 24-hours prior to commencement of plugging operation. Set a CIBP @ 4702'. Set a 50' cement plug from 4652' to 4702'. Set a 100' cement plug across the Mesa Verde top from 1908' to 2008', top @ 1958' inside and outside of 5-1/2 casing. Set a 100' cement plug across top of PC from 1240' to 1340', top of PC @ 1290' inside and outside of 5-1/2 casing. Set a 100' cement plug across top of FC from 1031' to 1131', top @ 1081' inside and outside of 5-1/2 casing. Set a cement plug from surface to 320' inside and outside of 5-1/2 casing. Cut off wellhead. Install dry hole markers. Clear and remediate location.
