January 9-10th.

A. Set a CIBP at 4692' and spot cement on top to 4479' using 30 sacks cement.

B. Bring top of ^{mv}Gallup plug from 1915' to ¹⁸⁶⁷ inside outside 5 1/2" casing using 47 sacks cement, didn't hold

C. Second attempt, bring top of ^{mv}Gallup plug to 1759' inside outside 5 1/2" casing using 47 sacks cement.

D. Set Pictured Cliffs plug from 1175 to 1075' inside and outside 5 1/2" casing using 17 sacks cement.

E. Place the Fruitland Plug from 850' to ⁷⁵⁰ inside and outside 5 1/2" casing using 47 sacks cement.

F. Place the surface casing shoe plug at 400' ³⁰⁰ inside and outside 5 1/2" casing using 47 sacks cement.

G. Place the surface plug at 175' to surface inside and outside the 5 1/2" casing using 150 sack cement to cover the Ojo Alamo interval.

H. Cut well head and install dry hole marker. Clear and remediate location.
