Elm Ridge Resources, Inc. proposes to plug and abandon the CBU WI #3 in accordance with regulations. Production equipment will be removed and tubing will be used to pump plugs. Perforate and squeeze will be used unless casing can be recovered from specified intervals. Note: Well has 4-1/2" liner (flush joint) set @ 4007'. Cement circulated to surface. Bradenhead did not circulate. Proposed procedures as follows; Notify BLM and EPA 24-hours prior to commencement of plugging operation. Set a 224' cement plug across Gallup from 4638' to 4862, top @ 4688'. Set a 100' cement plug across Mesa Verde from 1884' to 1984', top @ 1934' inside and outside of liner and 5-1/2" casing. Set a 100' cement plug across top of PC from 1178' to 1278' inside and outside of liner and 5-1/2" casing. Set a 100' cement plug across top of FC from 837' to 937', top @ 887'. Set a plug from surface to 244' inside and outside of liner and 5-1/2" casing. Cut off wellhead. Install dryhole markers. Clear and remediate location.
