DETAILS OF WORK

Total Depth 2325'.

This well was previously abandoned from 2233' - 2285' with no results. The well was then drilled to 2325' with salt water encountered. It is intended to plug and abandon this well using the following procedure.

1. Set cement retainer in bottom of casing, pump 50 sacks regular cement into formation and put 5 sacks cement on top of retainer.
2. Cut and pull casing at some point above 1340' and place cement plug in top of casing, in hole and up to 1050'.
3. Set 50 sacks cement plug in top of surface casing with 4' joint of 4" line pipe as permanent marker.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
