**Ka-De-Pah Well No. 2.** On February 1, 1958, 5-1/2" casing was set at 4979' with 100 sacks cement. After waiting on cement for 5 days, on February 7, 1958, casing and water shut-off were tested with 2500 pounds (special test) for 15 minutes which held with no drop in pressure.
