DETAILS OF WORK

Drilled 13-3/4" hole to 240' KB. Ran 8 joints, 9-5/8", 32.30f, N-40 Casing landed at 234' KB and cemented with 175 sac 2 1/2 CMC regular cement. Displaced cement to 214' KB with good returns to surface. Waited 24 hours, drilled out cement and tested casing with 300 f for 30 minutes. Held OK.
