Well spudded June 15, 1965. Set 3 jts. (120') of new 13-3/8" OD 35.8# Arnee SMSJ R-3 casing at 132' and cemented with 110 sacks of cement by the Pump & Plug Process. Cement circulated to surface. Plug down at 11:30 P.M., June 15, 1965. W.O.C. 24 hrs. Pressured up to 600# for 30 mins. and casing tested OK. Drilled out cement plug and pressured up to 600# for 30 mins. and casing shut off tested OK.
